- 1. The rebate applies to residents of the Regional District of North Okanagan for repairs to damaged or worn clothing and textile items to restore items to usable condition and prevent their disposal and replacement with a new item.
- 2. Expenditure must be made during 2022. All submissions must be received within 60 days of the date indicated on the receipt. Final submission date is January 31, 2023.
- 3. A legible sales receipt from the service provider or retailer and two required photos must accompany the completed rebate form. The receipt must indicate; name, address, and phone number and date of transaction. Incomplete applications will be rejected. The two required photos are one showing the item in need of repair (before repair takes place) and one showing the completed repair (after the repair).
- The rebate amount is for up to a maximum of \$25.00. The minimum rebate is \$10.00. Maximum one rebate per North Okanagan household. There is a limited number of rebates available per year.
- The rebate does not support additional products that generate waste or may be remaining after do it yourself (DIY) repairs such as glues, sewing kits or other equipment.
- The applicant shall indemnify and hold harmless the Regional District of North Okanagan, its directors, officers, and employees, from and against all liabilities and damages, in any way based upon or attributable to the applicant's participation in the Repair to Reduce Waste Rebate Program.
- 7. The Regional District of North Okanagan reserves the right to alter, cancel, or discontinue this program at any time, and to reverse the rebate if the information provided by the applicant is inaccurate or false, or if the terms and conditions of this program have not been met. Rebates will be assessed based on evidence that a repair has been made that has restored the item to be used and prevented it from being discarded.
