CODE OF CONDUCT

Welcome to sncəmələqtn Public Agricultural Park! Our mission is to promote the development of diversified and innovative agriculture by local farmers, offering appropriately-sized agricultural plots at reasonable fees, while emphasizing regenerative agricultural practices. To support this mission and ensure the orderly operation, safety, security, and maintenance of the sncəmələqtn Agriculture Park, we have established the following site Code of Conduct.

- 1. Respect for Agriculture and Environment** Respect the natural environment and wildlife within sncəmələqtn Agricultural Park. Avoid damaging or disturbing plants, animals, and their habitats.
- 2. Responsible Land Use** Use park facilities, agricultural lots, and resources responsibly and sustainability. Minimize waste, conserve water, and practice environmentally friendly farming techniques.
- 3. Safety First**
 - Stay on designated paths and trails.
 - Children must be supervised by adults at all times.
 - Climbing on fences, trees, or any other structures is not permitted.
 - Be cautious around farm equipment and machinery.
 - In case of an emergency, dial 911
- 4. Respect for Others** Treat all visitors, farmers, staff, and volunteers with respect and courtesy. Avoid disruptive behavior, harassment, or discrimination based on race, gender, religion, nationality, or any other factor.
- 5. Compliance with Regulations** Adhere to all park rules, regulations, and guidelines. Respect signage and designated areas within the park. Failure to comply may result in expulsion from the park premises.
- 6. Hours of Operation** The park is open to the public from dawn to dusk every day, except for special events or maintenance closures. Please note that access to the park outside of these hours is prohibited, and visitors are kindly requested to vacate the premises before dusk.
- 7. Parking**
 - Please park vehicles only in designated parking areas.
 - Parking is available on a first-come, first-served basis.
 - Do not block entrances, pathways, or emergency access points
- 8. No Unauthorized Activities**
 - Engage only in authorized activities within sncəmələqtn Agricultural Park. Avoid activities that may cause harm to the environment, wildlife, or other park users.
 - Smoking and vaping are prohibited within the park premises.
 - Alcoholic beverages are not permitted within the park.
- 9. Spray-Free Practices** Embrace spray-free farming practices within sncəmələqtn Agricultural Park. The use of chemical herbicides or pesticides is prohibited. The use of chemical herbicides or pesticides may harm the environment, soil health, or human health. Utilize alternative methods for weed and pest control, such as mechanical cultivation, hand weeding, mulching, and integrated pest management techniques.
- 10. Community Engagement** Participate positively in the park community. Share knowledge, resources, and experiences with fellow farmers and visitors. Foster a supportive and collaborative environment within the park.
- 11. Cleanliness and Maintenance** Keep park facilities, agricultural lots, and common areas clean and well-maintained. Dispose of trash and compostables properly in designated bins. Report any maintenance issues or concerns to park management.
- 12. Pet Policy** No Pets or Dogs on site
- 13. Respect for Property**
 - Respect the property of others within the park. Avoid trespassing on private agricultural lots or interfering with other farmers' operations.
 - Unauthorized harvesting or removal of plants is strictly prohibited.
 - Please do not damage or tamper with any agricultural equipment or installations
- 14. Reporting Violations** If you observe any violations of park rules or witness inappropriate behavior, report it to park management immediately. Your cooperation helps maintain a safe and enjoyable environment for everyone.
- 15. Enjoyment and Education**
 - Enjoy your time at sncəmələqtn Agricultural Park while also learning and appreciating the value of agriculture, sustainability, and environmental stewardship.
 - Educational tours and programs may be available at designated times.
 - School groups and organized tours must schedule visits in advance.
